# PHARMA STUDENTS GROUP DANCE COMPETITION



## Rules and Regulations:

1. Registration as delegate to 73<sup>rd</sup> IPC is mandatory for participants for participating in Group Dance competitions.
2. Only students pursuing Pharmacy courses are eligible for participating in this competition
3. A video of the performance less than 300 mb in size shall be uploaded in the Google Form given below on or before 25/05/2024 for scrutiny.
4. Only top 10 selected teams based on their performance will be selected for final round competitions to be held at the venue of 73<sup>rd</sup> IPC.
5. Attractive cash prizes will be awarded to the final round participants
6. The same performance submitted through video for scrutiny should be performed at the final round competitions with all properties and costumes.
7. A team should consist of a minimum 6 members and maximum 10 members
8. Total duration of performance shall be between 8-10 minutes
9. The dance performance should be based on the theme related to our Indian Culture/heritage. The theme can be chosen by the participants themselves.
10. Participants should avoid incorporation of Skit, Drama, Dialogues, Ramp Walk etc., during the dance performance.
11. The Dance should be confined to a maximum of 2- 3 songs, if necessary.
12. Participants should avoid fire, colors or any combustible substances as properties of performance
13. The participants should bring all necessary properties, Costumes etc by themselves.
